Maintenance Worker

Operation of all levels of equipment required for completion of job duties, including electrical, plumbing, fabrication of equipment, herbicide applications, and flood fighting. In addition to filling & placing sandbags, placing & securing tarps, driving wooden stakes with a sledgehammer, and tying rope. All district field personnel work on the maintenance and operation of the flood control project facility.

Essential Job Functions

- Operate construction and power equipment; transport equipment, supplies, and materials to the work site.
- Perform equipment excavation, trenching, and re-filling of the work area for the installation, maintenance, or repair of pipelines and related structures; perform pick-andshovel work.
- Clear and remove debris, trees, and brush from ditches, canals, and drains; construct temporary and emergency facilities and systems as needed; rebuild gates and respond to emergency leaks.
- Perform routine maintenance duties, including painting, mowing, removal of debris, and trash pick-up and disposal throughout the District.
- Drive dump trucks to haul supplies and materials or pull other wheeled equipment.
- Keep and maintain logs and records of work performed and supplies, materials, and chemicals used.
- Properly follows District and OSHA safety precautions.
- Perform calculations or mixture and application rates; apply herbicides and algaecides through a variety of direct and indirect methods; and spray from a truck or other methods.
- Ensure that all chemical storage units comply with State regulations.
- Perform any other duties as assigned, including but not limited to heavy manual labor and shoveling
